The decision is in response to changing Governance guidance and announcements relating to the second national lockdown which currently is in place until 2 December 2020

Background

The background to this decision is as detailed in the report titled "Gainsborough Christmas Market 2020." which is appended to this decision.

Reason for Urgency and Rationale for use of urgent Delegated Decision

Following the Government's announcement on 31st October 2020 introducing new national restrictions from 5th November to 2nd December 2020, certain businesses and venues are required to close or restrict how they provide goods and services for this period.

Gainsborough Christmas Market is due to be held on 5/6 December

Given the uncertainty around Covid restrictions in the near future, it is appropriate to consider options for the delivery of this year's Christmas Market. As the communication and promotion of the Christmas Market are important elements in the success of the event and these need to be issued imminently, an urgent decision is needed.

In making this decision three options have been considered. The full options appraisal, and rationale for the decision are contained with the report which is appended.

Notes of Consultation Relevant to the Decision

All acknowledged this was a difficult decision, and not one they wished had to be taken.

It was acknowledged and accepted that the uncertainty post lock down was a factor that made this decision even more difficult. It was unclear what would and would not be permitted post 2 December and with the planned event being so close to this date it left the Authority very little time to plan for any necessary additional measures which may be stipulated.

There was some discussion around the rationale for, not at this stage, cancelling the planned Farmers Market the week after. This was shared with Members and understood.

Whilst all were in agreement the only sensible option at this time, all points considered, was to cancel the Market, Councillors did place on record the unfairness of some of the national rules, particularly with supermarkets being free to operate.

Members felt it was important future markets were supported and considered, given the layout of the market place and limited number of traders, this should be feasible once there was clearer guidance from the Government.

Members felt it would also be worthwhile investigating holding an Easter/ summer event in replacement.

Decision

That the Gainsborough Christmas Market 2020 be cancelled.

1 Background

- 1.1 Gainsborough Christmas Market is due to be held over two days, December 5th and 6th 2020.
- 1.2 England entered second lockdown on 5th November, these restrictions are due to end on 2nd December, after which the country is expected to re-enter the previous area-based tier system.
- 1.3 Given the uncertainty around Covid restrictions in the near future, it is appropriate to consider options for the delivery of this year's Christmas Market. As the communication and promotion of the Christmas Market are important elements in the success of the event and these need to be issued imminently, an urgent decision is needed.

2. Options

- 2.1 Available options are to proceed with the Christmas Market as planned, postpone the Christmas Market to a later date in December or to cancel the event.
 - **Option 1.** Proceed with the event as planned This could help the town, its retailers and market traders start to make an early recovery from the second lockdown. However, there remains a high level of uncertainty around the level of restrictions, which will be in place in early December. It is unlikely that the Government will be encouraging events which could heighten the chance of spreading Coronavirus.
 - **Option 2.** Postpone the event and rearrange closer to Christmas This would make arrangements and promotion of the event more challenging, it is unlikely traders would commit to attending without certainty of the date of the event.
 - **Option 3.** Cancel the event This could result in a level of disappointment for residents, visitors and traders. However, having certainty around the decision would allow communication to be managed explaining the reasons for the decision. There are no income implications as traders are currently able to trade on the Market for free, however officers would attempt to negotiate a reduction in the cost of the contract with Marshalls Yard.
- 2.2 In order to comply with Covid related legislation, only traders selling goods deemed to be essential are currently allowed to stand on the Market. This will continue until regulations change.

3. Recommendation

3.1 Considering the commentary in this report, Officers recommend Option 3 - Cancel the 2020 Christmas Market event.
