Introduction

The purpose of this document

- This document provides a record of the publication that took place regarding the Fiskerton Neighbourhood Development Plan Area and related Neighbourhood Planning Body. The main methods used to promote the publication process are also documented, along with the main findings from the publication. As this was only a publication process and not a more open consultation, the response rate is not expected to be high.
- 2. This formal publication period provided members of the public and other key stakeholders an opportunity to submit comments on the proposed neighbourhood plan area and proposed neighbourhood planning body for Fiskerton. The proposed neighbourhood planning body is Fiskerton Parish Council and the proposed neighbourhood planning area is shown in appendix 1 along with the rest of the parish council's application.

Regulations and government guidance

- 3. The regulations associated with this first stage of neighbourhood planning provide guidance on the criteria to be included for this phase. Within this publication, we as the local planning authority must publicise on our website:
 - a copy of the area application
 - details of how to make representations; and
 - the deadline for the receipt of those responses and representations, being not less than 6 weeks following the date on when the application is first publicised¹

Publication timescales

4. The publication period for this stage of the neighbourhood development plan process must cover a minimum period of six weeks¹. The proposed publication period is from the 18 July to the 29 August 2014.

Timescales break down as follows:

Publication period 18.07.14 – 29.08.14 Cabinet meeting date or delegation 14.10.14

Previous consultation

5. This matter has not been the subject of previous consultation. The parish council are at the earliest stages of their neighbourhood plan development process.

Fiskerton Parish Council as the appropriate qualifying body herewith formally advises of their intention to prepare a Neighbourhood Plan.


This follows the resolution by the Parish Council at the Full Council meeting on 30th June, 2014.
