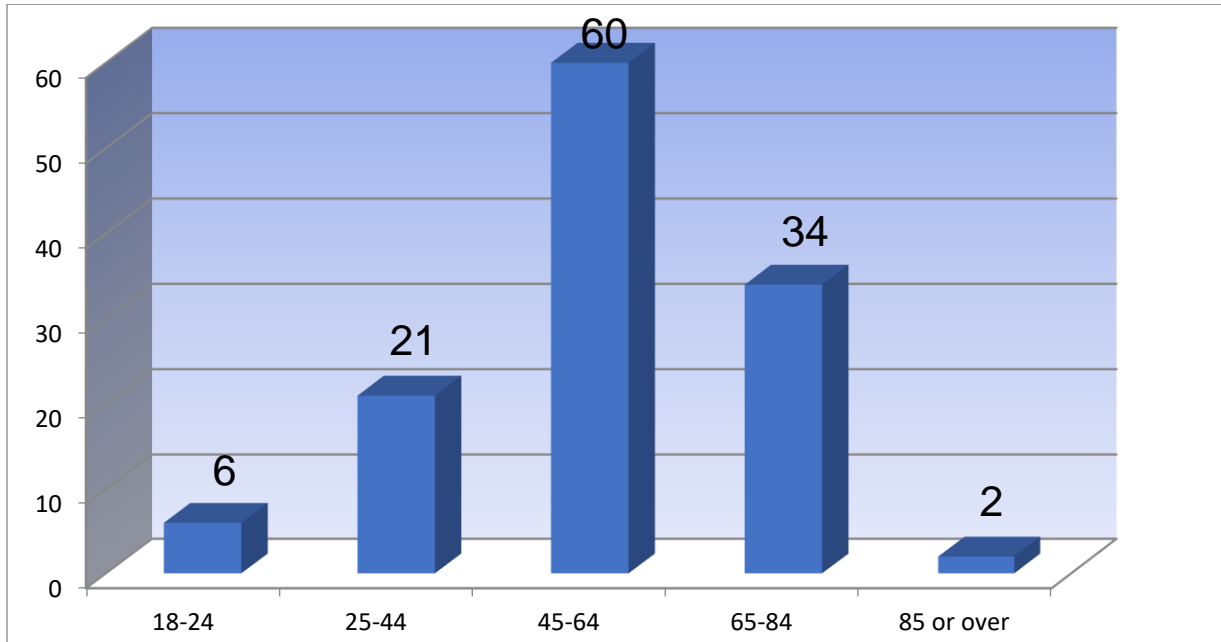

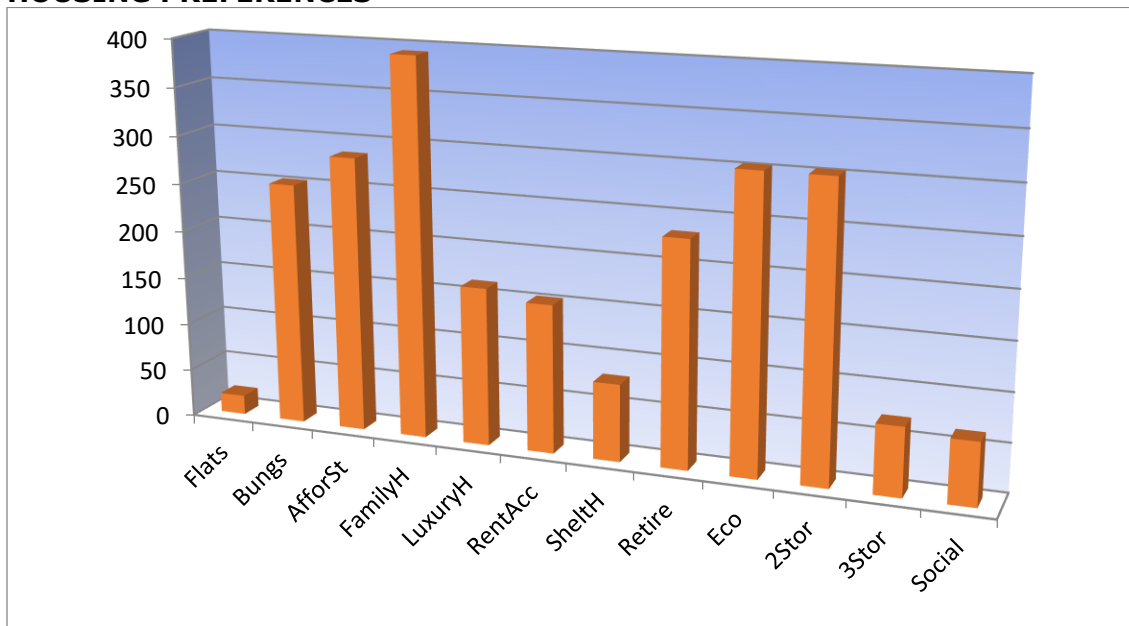
AGE DISTRIBUTION



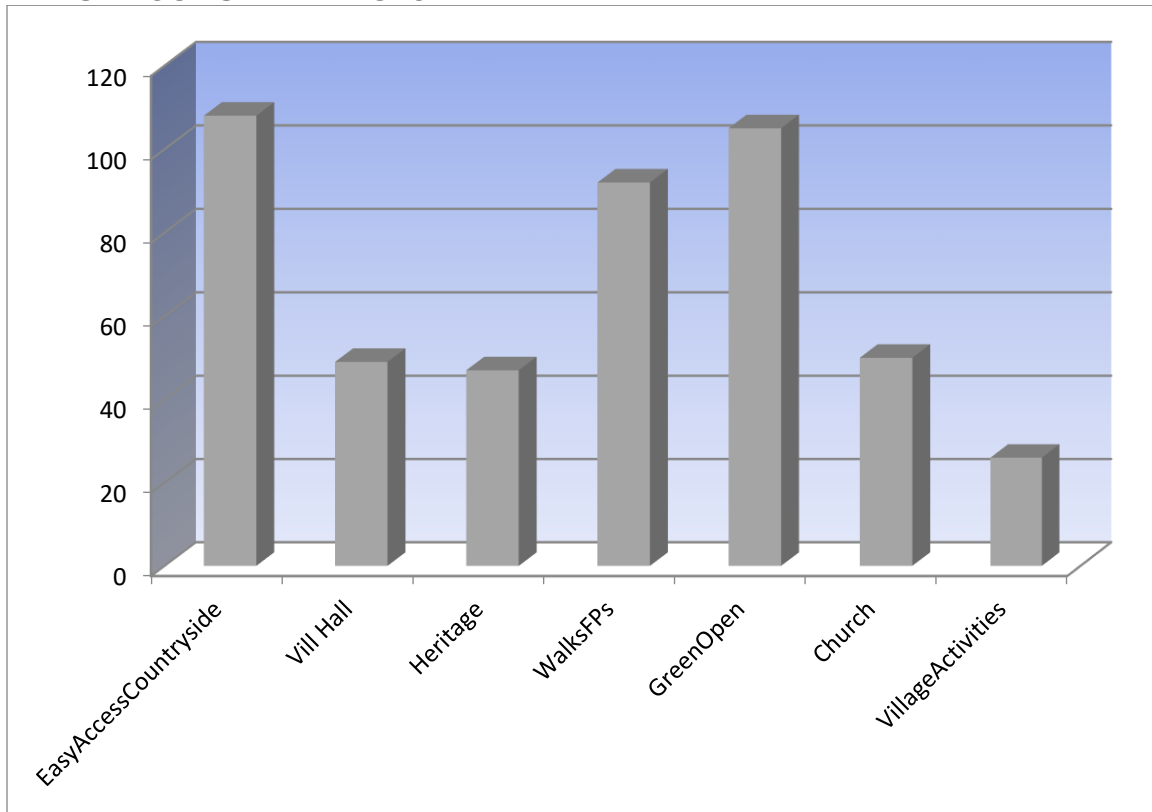

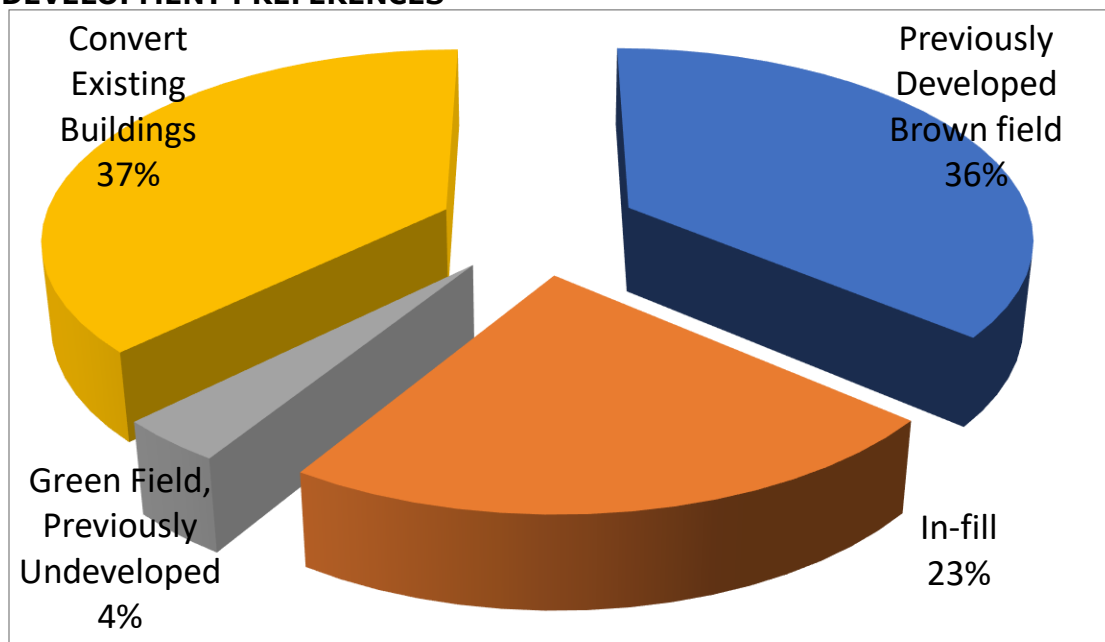
HOUSING PREFERENCES



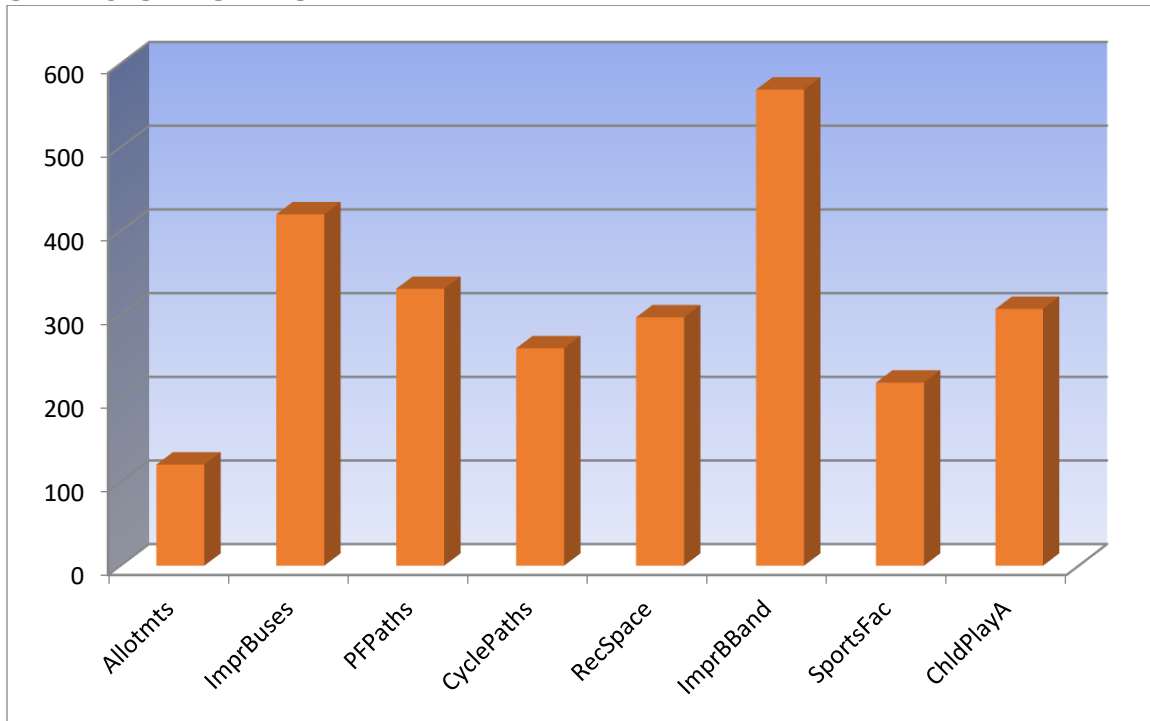

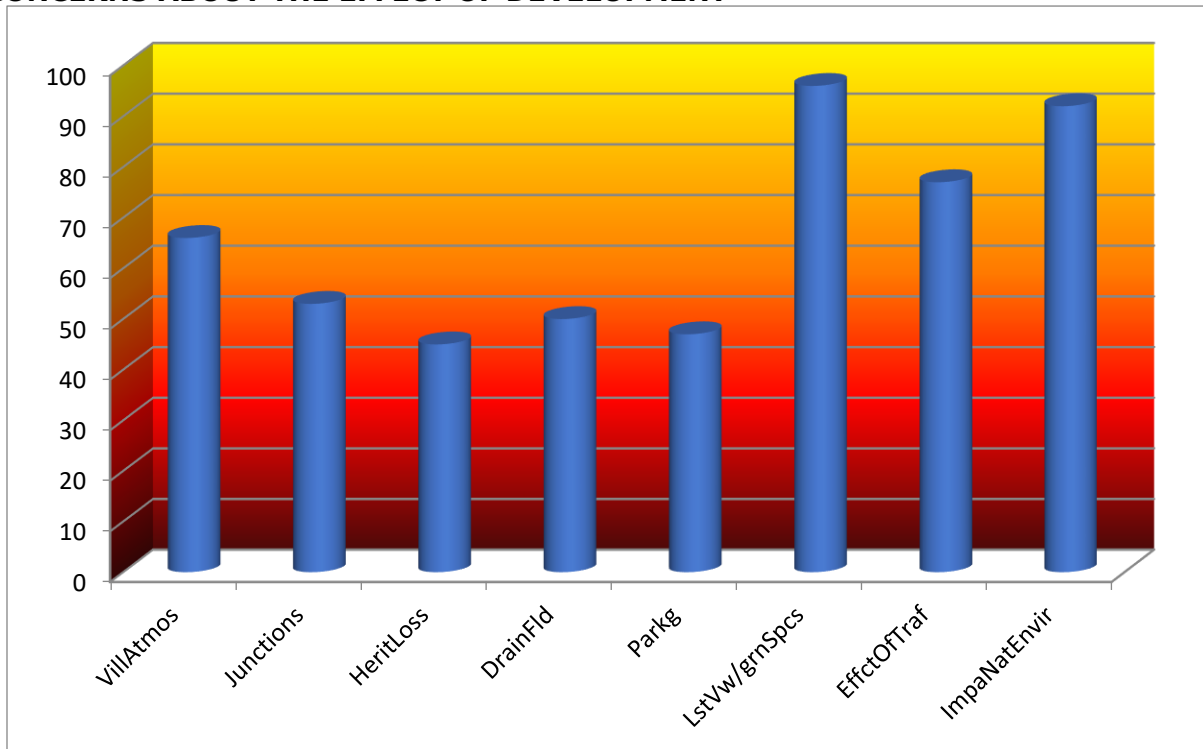
DEVELOPMENT PREFERENCES

Question 7. Which areas in Spridlington would you like to remain free from Development?

Leave Sprid as it is.

NE end of Owmbly Rd near Parish View Area, Green Field site SE end Faldingworth Rd.

Pasture to the East of the Parish Viewing Area

No estates behind private dwellings. Please keep to "ribbon" development.

The open ground alongside Owmbly Road, opposite The Old Vicarage and Wold View.

Vacant piece of land adjacent to "Netherwood" on Owmbly Road.

The paddock field on the east side of Owmbly Road at the north end bordered by the verge which is now a community asset.

Field on east side of Owmbly Road as you exit village (in direction of Saxby). It's within conservation area.

Not extending the boundaries of the village.

The paddock viewing area at the north end of Owmbly Road

The paddock viewing area at the north end of Owmbly Road and the field and view from the rear of the houses on Owmbly Road.

Land next to seated area at end of Owmbly Road

All land which sits behind existing houses and boundaries. Any development should continue to maintain the "strip roads" throughout the village.

Land behind existing housing to preserve the strip village as it currently exists. I believe this is the current West Lindsey Planning guideline.

The "centre" of the village ie along roads from junction of Church Hill/Owmbly Road/Faldingworth Road for, say, a distance of 100m from junction.

Much depends on the type of housing, location and access. So an ecohome might be far more attractive on greenfield site and less intrusive. I would not wish to see spread - but I do think there are opportunities to build "deeper" into village. By that I mean, many properties seem to have land which may be accessible.

The area identified as a community asset at the northern end of the village on Owmby Road with open views to the Wolds. The site of the former village pond (the sheep dip) on Cliff Road - it would be nice to see this returned for community use (as I believe it formerly was). Do the current occupiers have full or possessory title? The paddock land between Church View Farm and Church View House. Anything outside present curtilage

- 1) Land to the north of "Netherwood on Owmby Rd as the area by the road provides a good view of the Wolds. 2) The small field between "Pond view" and "Tres Escalares" on Cliff Rd opposite the junction. 3) Any development outside the village boundary. 4) the field opposite "Stony Rise" on Faldingworth Rd.

Areas which have been demarcated as "conservation" areas. Farm land which is still in use and likely to be in use in the future. Any areas that would be prone to flooding once buildings have been erected. Anything that would spoil the character of the village. Changes that would influence traffic flow.

The green space around footpaths. I would prefer the developments to be within the village rather than extend into open countryside. **Parish Viewing Area** - we enjoy going for walks there and use the benches (conkers).

Viewing area on Owmby Road as it is the closest that village has to a Green.

The Gallops - we certainly don't want any more biodigester type monstrosities built along it - however superficially "green" they are. The view of the wolds from Owmby Road needs protecting.

The far end of Owmby Road (as you leave the village) on the right, where there is a fine (green) view across to the Wolds. I'm sad to see a hedge planted bang in front of the seats designed for enjoyment of the view.

Greenfield sites should be protected. There is sufficient opportunity to develop infill sites/brownfield sites.

Very strongly against any development in the "Ox Pond" (Sheep Dip) field opposite T-junction to Welton. That field should still be common land. Against development on fields on the village curtilage extremities which include (NE end)field on the Owmby Road, (SE end) field on the Faldingworth Road, field on Church Hill/Welton Road - the one which has an ancient monument on its site.

Ox Pond (Sheep dip) opposite Welton junction. No development on greenfields on edge of village.

Any of the land/farmland just outside of the village. It's good to have a good distance between neighbouring villages and any development of properties to be done within the village.

ALL OF IT!!

The area in question, at the end of Owmbly Road where there is a planning application going through. I **don't want** any more development in Spridlington. I accept that the village has to produce nine sites for building, but that wouldn't be what I want.

Any existing "Greenfield" site within the Parish.

Any area that is currently greenfield and undeveloped should remain that way as it could impact the essence of village life.

Owmbly Road beyond current properties.

Land belonging to "New Haven" on Faldingworth Road.

Land behind "The Old Barn" on Faldingworth Road.

No developments on **all approach roads** to Spridlington! One of the "charms" of Spridlington is its trees, giving the village a sheltered, compact and private nature in approach, despite the fact that 4 country roads converge on it, with relatively high density traffic passing through it. This I feel, needs protecting. So any thoughtless developments on any of its fringes would spoil Spridlington. There are very few places which are suitable for property development **within the village** and any that are promoted for development must be seriously scrutinised and challenged. If you can "tuck" 9 new properties into any existing spaces within the village over the next 20 years, without spoiling the ambience of Spridlington, then you will have done very well. I can't give specific locations because of ambiguity in describing them for this purpose.

Agricultural land on the fringes of the village at present used for grazing of livestock.

Either side of Faldingworth Road east of existing dwellings.

Ox Pond (Sheep dip) field opposite T-junction to Welton.

Land opposite Welton junction. Land down wetherwalk.

The field at the end of the village on Owmbly Road towards Saxby and all infill developments. I would also like to say that I am really disappointed that the landowner has planted a hedge on the aforementioned field and I hope that it is not going to obscure the views from the benches on the field.

All infill plots

No development to be allowed now or in the future on the "conservation open space" on the corner of Faldingworth Road and Owmbly Road. This is vital to the village feel with its mature trees and grass paddocks. No development to be permitted in the farmyards down the Weatherwalk road. This is a beautiful and traditional area enjoyed by many villagers who walk down there. The road is not suitable to carry any volume of traffic with existing households already parking cars on the road restricting access; and there being no room for any form of footpath. It is also outside the boundary of the village curtilage. No development on Pond field (Sheep dip) - the field opposite the Welton junction. This is a very traditional "green space".

There are several sites within the village which I feel would be suitable for development without changing the heart of the village. Houses could be built within Church View farmyard - this has direct access to the highway and would not impact the traditional feel of the village. Infill development on the Cliff Road would be ideal - it would link the council houses to the village and again would have direct access to the highway. Although a greenfield site, houses positioned here would not spoil the centre of the village. The redundant buildings within Spridlington House yard would also convert to several dwellings without any external change in appearance.

No development down Wetherwalk road, as the highway is unsuitable, houses have blind exits and the road is not wide enough for a footpath. One house has no off street parking. No development on valuable green open spaces along Church Hill; Faldingworth corner; opposite Welton junction. No development beyond the existing housing line on each side of any of the roads within the village curtilage

Poorly sited development would have an adverse effect on my ability to carry out my business. Housing development must not be allowed to take place that may have an effect on any of the village's conservation ponds.

The Church View farm yard would make an excellent site for houses. Also on the Cliff Road on the north side would accommodate several houses, and give direct access to the highway. The redundant barns at Spridlington House would also convert to dwellings.

The field at the corner of Faldingworth Road and Owmbly Road. Weatherwalk - I regularly put my mares and foals out in the field up there and it is not suitable for development. I also like all the sheep and traditional farm yards & buildings. It would be horrid all built up with houses - a nasty cul-de-sac which would be all stuffed in unnecessarily.

I wish to return to Spridlington to farm. I am studying Agriculture at university and part of my life strategy ongoing is to convert the grainary in the barn at Spridlington House to a single person flat and then run a business from Spridlington, farming Lincoln Red Cattle.

Old farm buildings that are no longer in use and are starting to get into disrepair, could be converted. This would enable green areas to stay as farm land.

Field on Owmbly Road where the sheep are opposite Spridlington Hall.

The grass field that runs parallel with Owmbly Road behind the mainstream of houses.

Question 8. Other concerns about development in Spridlington

New homes always seem to be built on a large scale. These houses then only become occupied by retired couples. I would also not like to see the removal of any trees, to make way for housing.

Spoil village, (pressure on) Doctors' surgery spaces. No broadband.

My greatest concern is that the projected number of dwellings (9 over 20 years) could increase: as currently planned the numbers appear reasonable BUT! If these numbers/time scale were to change, then all of the above would be of great concern.

The junction Hackthorn Road/Cliff Road has bad visibility, more traffic would make this more dangerous.

A major concern is the increasing amount of traffic through the village, especially large heavy lorries using the route as a short-cut between the A15 and A46 - along Cliff Road, Church Hill and Faldingworth Road. Weight restrictions should apply! Conservation is commendable - but not when it takes away the autonomy of local landowners to control trees on their own land. Trees are beautiful and necessary, but not when they constitute a hazard or a danger to the residents. Some of the pavements are in a poor state of repair and constitute a danger, especially to elderly residents - and especially the section along Owmbly Rd near the Village Hall and beyond. The wall on the Church Hill side around the Church Yard needs attention and bulges outward, with loose stones occasionally falling off. Another concern is the damage done and mess left by contractors.

Concerns would be to ensure that a) Visual appearance is enhanced b) Building future character of the village c) Building future amenities d) Developing greater community spirit - engagement e) Avoiding large scale builders. These concerns can be met easily.

The main concern for me would be if a large development proceeded, as the ones are in nearby Welton & Dunholme. We came to live here because almost every property is different.

Vehicles speeding despite signage - visibility issues re: overgrown hedges/verges etc - General wear and tear of roads/footpaths

All the above are of concern, but it is believed that if expansion is on the outskirts of the village and carefully planned, most problems could be avoided. Big trucks should be banned from driving on our roads, as they destroy the surface and have difficulty negotiating the tight corners.

I would not want to see sheltered housing/housing for groups with limited mobility as they would potentially feel isolated. Any new development must enhance the village and be in keeping with existing housing stock. Speed control measures on Faldingworth Road may be needed if an increase in traffic occurs.

Not that 9 more houses will make much difference (to the village atmosphere). I think Spridlington is essentially a small village community without (thank God) a shop or pub or surgery, lived in by those who like to live surrounded by open countryside. Any future development should, in my view, be attractive to people who want to live in this sort of village (including any youngsters who've been brought up here and want to remain - can affordable houses be earmarked in this way?

Poorly sited development would have an adverse effect on my ability to carry out my business. Housing development must not be allowed to take place that may have an effect on any of the village's conservation ponds.

Overcrowding this village would be a concern of mine if property development was to increase.

Far too much traffic goes through the village from all directions and it also goes far too fast.

there is no infrastructure in Spridlington to support further development - no shop, sparse public transport, local shops not walkable as no footpaths out of village. How would social housing be supported without tenants having transport?

We chose to live here because of the relative lack of traffic and the wealth of green spaces and access to "nature walks".

(Loss of green spaces emphasised with 3 ticks) Difficult to add anything to the above list - The village is surrounded by beautiful countryside - land that is well farmed, tidy and we are afforded lovely views over to Lincolnshire's highest land - The Wolds. Agricultural practices are diverse - we have livestock and arable. The village is built around farms and we are lucky to live in one of Lincolnshire's beautiful villages - we need to keep it that way - so approach development with care. Lincolnshire's great asset is its rurality - villages, churches, access and walks, tranquility and wildlife - we have this in Spridlington - let us keep it that way, for future generations.

Future developments will not add to the village - no shops, schools, other public amenities mean people live in a dormitory village which adds nothing much to the common life and building up a sense of community.

Improved footpaths, Vehicle Activated Signs (as on Hackthorn Rd, Welton) for Owmbly and Faldingworth Roads.

Footpaths need resurfacing on Owmbly Road (so uneven it is easier to walk on the road). Footpath needs extending to the edge of the village on Owmbly Road. Curbs need putting in on the East side of Owmbly Road. Street light outside Spridlington Hall not working.

Would like to see the development of "circular" footpath/permitted access path that loops round village creating walk that can be enjoyed by families, dog walkers, visitors etc. This would link up existing public rights of way so can have a varied length of walk but can come back in a loop without going miles!

A children's play area could go hand in hand with a recreational space, and need not be very large such as at the bottom end of Owmbly Rd, under the Chestnut trees. A bus 3 times a day would be good - not too many buses needed trundling through the village. Public footpaths need to be more clearly marked.

There are several sites within the village which I feel would be suitable for development without changing the heart of the village. Houses could be built within Church View farmyard - this has direct access to the highway and would not impact the traditional feel of the village. Infill development on the Cliff Road would be ideal - it would link the council houses to the village and again would have direct access to the highway. Although a greenfield site houses positioned here would not spoil the centre of the village. The redundant buildings within Spridlington House yard would also convert to several dwellings without any external change in appearance.

The Church View farm yard would make an excellent site for houses. Also on the Cliff Road on the north side would accommodate several houses, and give direct access to the highway. The redundant barns at Spridlington House would also convert to dwellings.

I wish to return to Spridlington to farm. I am studying Agriculture at university and part of my life strategy ongoing is to convert the grainary in the barn at Spridlington House to a single person flat and then run a business from Spridlington, farming Lincoln Red Cattle.

Broadband speed (or lack of it) is a big issue that needs to be addressed urgently. As a parent of two teenagers there is little for them to do in the village + the lack of transport (buses) into Welton/Lincoln means that they are isolated. Given the amount of Beautiful countryside on our doorstep there are surprisingly few public footpaths. Cycle paths would be great - the roads can be dangerous - I am concerned that my son has to cycle into Welton on Hackthorn Road which can be busy.

A village pub

This is a great place to live because of the village being away from amenities such as supermarkets, pubs, post-offices. It isn't what the village lacks it's the advantage that it gains!

If you want more housing, amenities, noise, overcrowding and litter move to Lincoln or Nottingham or London and leave us in peace!!

Please leave Spridlington as it is!!!

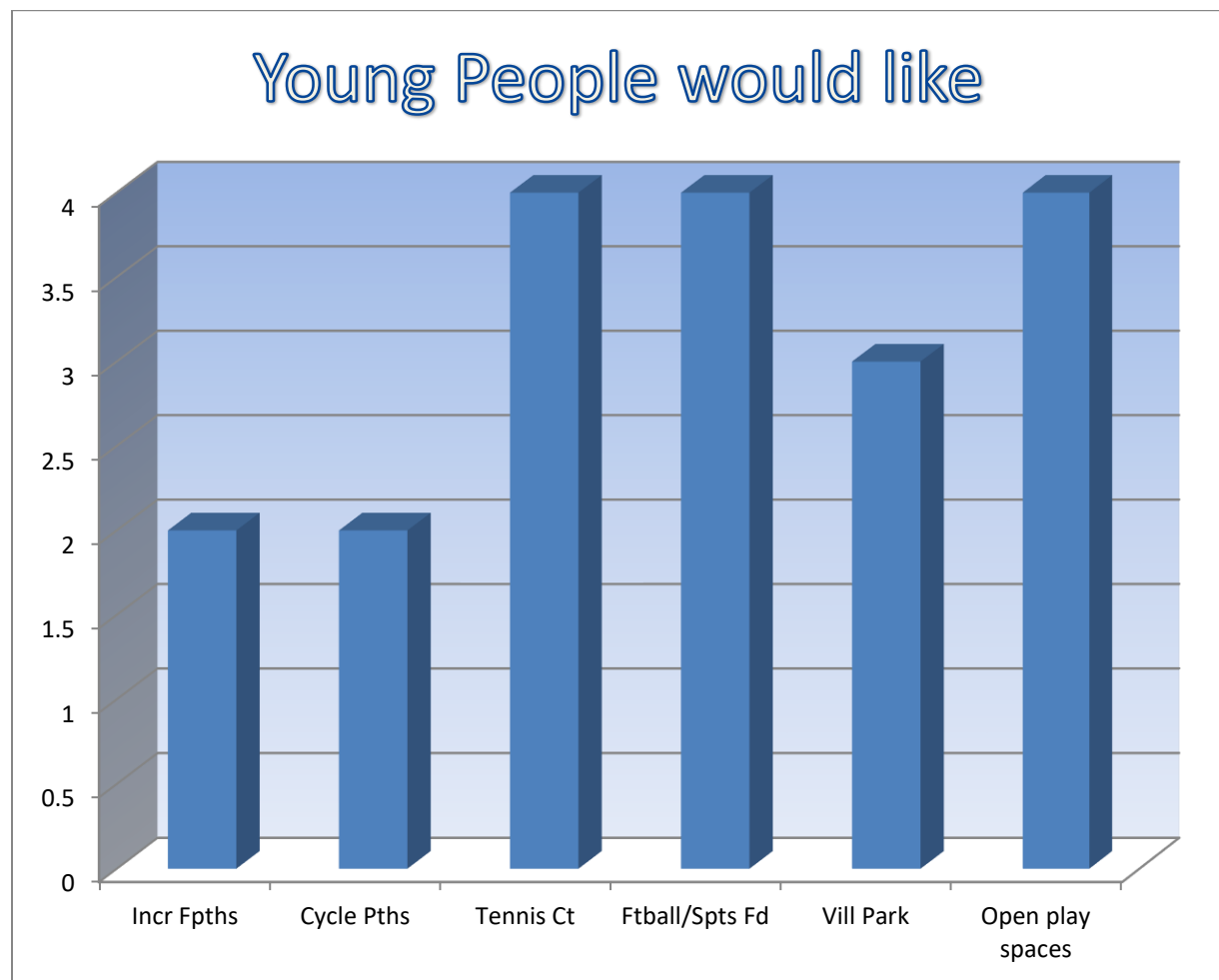

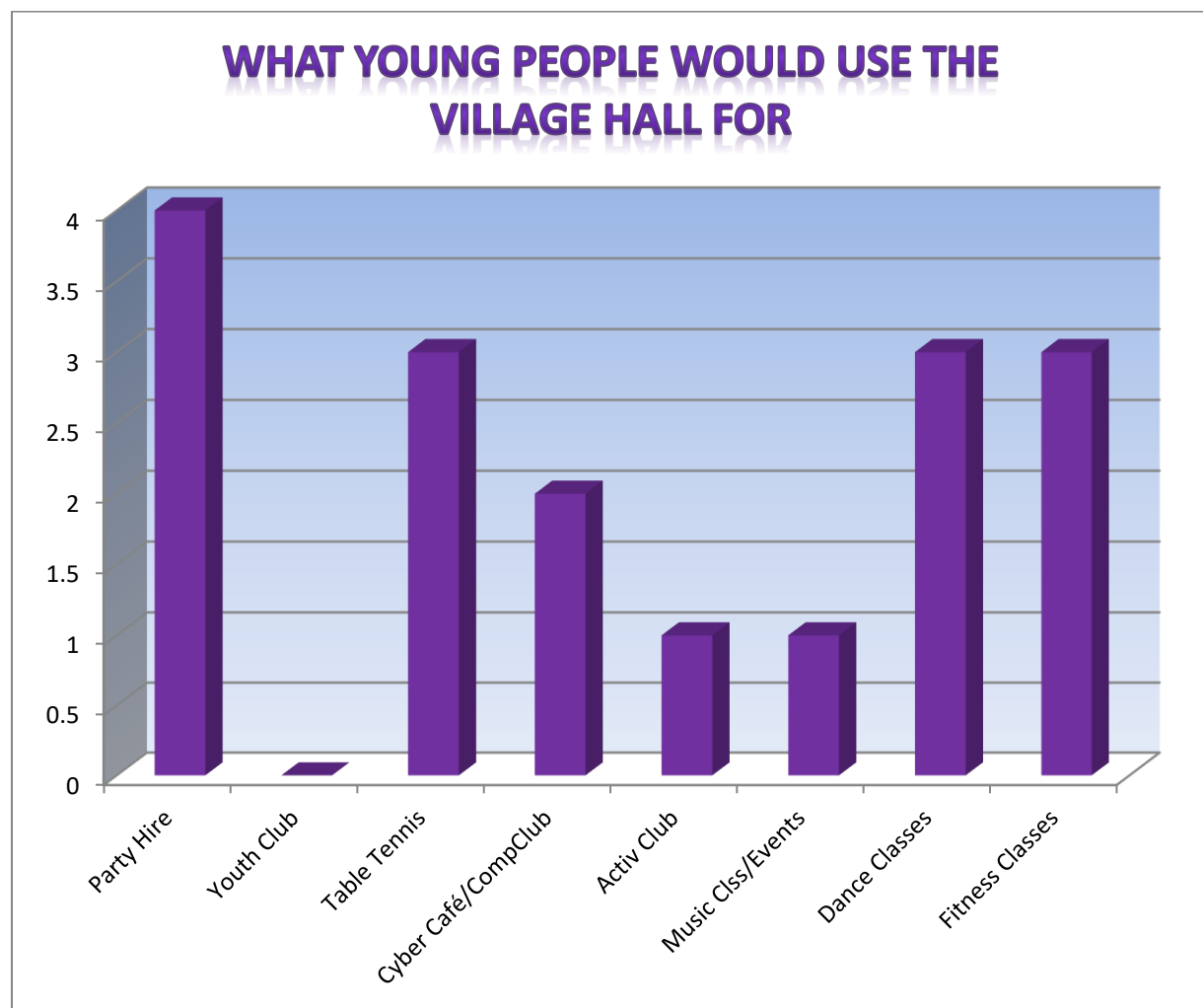
