Consultation Statement

Introduction

The Welton Neighbourhood plan (NP) has been prepared in accordance with the Town and Country Planning Act 1990, the Planning and Compulsory Purchase Order Act 2004, the Localism Act 2011, the Neighbourhood Planning (general) regulations 2012 and the Directive 2001/42/EC on Strategic Environmental Assessment (SEA). The NP establishes a vision for the future of the Parish and sets out how this vision will be realised through planning and managing future land use and development change over the lifetime of the NP.

The NP is a planning document prepared by the local community. It is legally bound and once it has been formally 'made' by West Lindsey District Council (BDC), it must be used by:

- Planning Officers at WLDC when assessing planning applications; and
- Applicants who are preparing planning applications.

In order for this NP to carry sufficient 'weight' when assessing planning applications, it must be examined by an independent examiner who will assess the plan for its conformity to a set of 'basic conditions' as set out in the NP regulations. If successful, the Plan, along with any recommended amendments, will be subject to a public referendum.

The Aims of this (Regulation 14) Consultation

The aims of Welton Neighbourhood Plan consultation process were:

- To involve as much of the community as possible throughout all consultation stages of the Plan development, so that the Plan was informed by the views of local people and businesses from the start of the process;
- To ensure consultation events took place during the consultation period in order to allow members of the community to 'have their say' during the process;
- To engage with a wide range of people as possible, using a variety of approaches and communication and consultation techniques; and
- To ensure the results and findings of the consultation are fed back to the community for them to view.

Regulation 14 Consultation

The Regulation 14 consultation is a statutory six-week (minimum) consultation period as detailed within the NP regulations 2012. The Regulation 14 consultation is where a draft NP is available for the local community as well as statutory consultees to provide comment and input into the process. Any suggested amendments to the Plan are detailed in this statement and a decision on whether these suggested amendments has been made are also detailed.

The draft NP Plan was sent to all statutory consultees such as West Lindsey District Council, the Environment Agency, Historic England etc. A list of all relevant statutory consultees can be found from page 6.

What is a Consultation Statement?

This Consultation Statement relates to the draft Welton NP and has been prepared to fulfil the legal obligations of the NP Regulations 2012. Section 15(2) of parts of the Regulations sets out that a Consultation should contain the following:

- Details of the persons and bodies who were consulted about the proposed NP;
- Explain how they were consulted;
- Summarise the main issues and concerns raised by the persons consulted; and
- Describe how these issues and concerns have been considered and, where relevant, addressed in the proposed NP.

This statement provides an overview and description of the consultation period on the proposed Welton NP which ran from 12th November until the 23rd December 2015.

The separate document entitled 'Consultation Summary¹' sets out the list of methods, events and publication that have led to the production of this draft of the Welton NP.

Methodology

This section of the consultation statement outlines the approach taken by the Parish Council to consult on the Draft Neighbourhood Plan. Several methods were adopted to ensure that all relevant bodies and parties were informed of the consultation period, as well as ensuring that local residents were made aware of the consultation period and provided with opportunities to provide their views and comments.

The NP steering group produced a small A5 sized leaflet and a poster (below) that advertised the consultation on the NP and the four public consultations events. The posters were put up around the town and within various venues and facilities, including local shops.

Public Events/ Displays

During the consultation period, the NP steering group organised a number of public events whereby it gave members of the local community to attend and gain further information about the NP process and the current consultation. Four separate public events were organised, including:

Event 1:

Main issues raised:

- The majority of people agreed that the NP was a good idea and the majority of policies were appropriate to manage future development;
- Concern over the lack of existing infrastructure to accommodate large scale future development;
- Increase in the level of traffic;
- Concern over the proposed infill policy and the scale of development;
- Concern over the current level of parking in the village centre

Event 2:

Main issues raised:

- The majority of people agreed that the NP was a good idea and the majority of policies were appropriate to manage future development;
- Concerned over the level of parking in the town centre;
- Believed the village needed a greater level of family sized housing;
- Believed the local landscape needed to be preserved.

Event 3:

Main issues raised:

- The majority of people agreed that the NP was a good idea and the majority of policies were appropriate to manage future development;
- Concern over the level and location of proposed development in the village;
- A new doctors is needed;
- Concern over the lack of local businesses in the village

Event 4:

Main issues raised:

- The majority of people agreed that the NP was a good idea and the majority of policies were appropriate to manage future development;
- The local businesses and services needed protecting;
- New development should provide family and older persons accommodation;
- Concerned over an increase in traffic into the village.

Alternative to a Neighbourhood Plan

- Residents will have no collective proactive input for future developments
- Developers can and will make decisions on the location, timing and extent of their planning applications independently of the community

DO YOU AGREE?

Welton's Parish Vision is to be a self sustaining and vibrant Parish that offers its residents a safe and friendly environment in which to live, work and play, ready access to the city of Lincoln and the surrounding countryside and enjoyment of a wide range of leisure and social activities. The Neighbourhood Plan will allow the Village to continue to evolve to the benefit all within its rural setting.

A village-wide Housing Needs Survey was undertaken by Community Lincs (commissioned by West Lindsey District Council) in May 2012. This provided important information to guide the Neighbourhood Plan.

The Neighbourhood Plan must be developed by the village for the village and requires a majority approval of residents voting in a referendum. The Neighbourhood Plan Committee is keen to hear from everybody, to keep everyone up-to-date with progress and able to comment. INTRODUCTION

The Welton-by-Lincoln Neighbourhood Plan is now entering its statutory six week public consultation stage, before going to independent examination and if successful, to a referendum for the residents of Welton to have their final input.

This guide explains what a Neighbourhood Plan is and its importance to the village.

You will also find a list of the dates, times and venues of drop in events to be held over the coming weeks and other ways in which you can examine the plan.

Your comments at this stage are important as they can still influence and be incorporated into the Plan, before its examination stage, after which only the examiner can recommend changes.

WHAT IS IT?

The power for a Parish Council to commission a Neighbourhood Plan was at the core of the Localism Act 2011 which is intended to give communities such as ours, a greater say in local government and how they develop. The Act also specifies:

- a) It should be community led
- b) Accurately, but realistically reflect the views of the community
- c) Have a sound evidence base

d) Take into account National, European and Local legislation

In April 2013, the Parish Council formally launched the Plan at its Annual Parish Meeting held in the Village Hall. Members of the community were invited to form a Working Group supported by, but independent of the Council, to prepare the Plan; in effect a blueprint for Welton over the next twenty years.

The Plan comprises three fairly complex documents and it is neither practical nor financially prudent to deliver them to each household.

PART I is the **Scoping Report**, as its name implies it sets out the content and scope of The Plan

PART II is the **Sustainability Assessment** on which The Plan's policies are based

PART III is the actual **Neighbourhood Plan** itself which explains the issues and lays out policies to address them

IS IT IMPORTANT?

Most definitely!

Unlike the old Parish Plans, Neighbourhood Plans are a Statutory Instrument (Law), especially in planning matters and this legal right has been upheld by the High Court. This judgment also means that in the absence of an effective District Council Local Plan, our Neighbourhood Plan, once adopted, must be taken into consideration by those preparing the awaited

Central Lincolnshire Local Plan that is still in early preparation and unlikely to be ready until late 2016.

Once adopted, the Plan would not only give Welton more say, but open up the opportunity for funding, both from developers and other bodies that can be used to benefit the village as a whole.

General:

Welton-by-Lincoln needs a Neighbourhood Plan, which will summarise the views of the local community in terms of:

Development - housing, shops, business and leisure facilities

Infrastructure - green open spaces, play facilities, Health Centre, schools, policing, etc.

All development within our local area must meet the needs of the present without compromising the ability of future generations to meet their needs.

The Government passed the Localism Bill in November 2011. It means that approved Neighbourhood Plans are protected by law and have to be taken into consideration when future development is proposed.

West Lindsey, Lincoln Central and North Kesteven District Councils have been directed by Government that there will be a requirement to build an additional 42,800 dwellings across central Lincolnshire in the future. Some of this will have to be absorbed into our village.

Volunteers of the Parish Council's Neighbourhood Plan working group have produced this questionnaire and it will greatly assist them, in the compilation of the plan if you could spare a few minutes to complete it. The questionnaire is anonymous and will be used to understand what the community opinion is as a whole and provide the basis of a draft plan, as a reflection of the consensus of the residents.

Our Neighbourhood Plan, if successful at the referendum stage will then be adopted and incorporated into the new Local Plan which means that we will have more say, not in the number of properties to be built, but in the type of housing, materials and location. Neighbourhood Planning is not just about property development it is about local people coming together to agree what you want our village to look like, where you want the new homes to be built and how they should look, where shops and offices should be located and green spaces allocated and much more resulting in better facilities for all the community.
