27 respondents wrote their age in the box and they were as follows:












Respondents greatest concern, should further development take place in Willoughton, was a 'change to village atmosphere' with 45 people selecting this, followed by 'loss of views / green space' with 43 selections, 'impact on the natural environment' with 40, 'impact on drainage / flooding' with 36, 'potential loss of heritage features' and 'effect on traffic' each received 34 selections, 'effect on road junctions' was the lowest selected concern, with 23 respondents saying this.



When asked 'Do you think there are changes needed to the following transport issues?' of 'Less parking on public footpaths' 26 respondents said 'Yes' and 17 said 'No'. For 'More Public Footpaths', 22 respondents said 'Yes' and 17 said 'No'. 'More off road Parking', 41 respondents said 'Yes' and 8 said 'No'. With regards to the 'Speed of vehicles through Willoughton' 51 respondents said 'Yes' and 6 said 'No'. For 'more cycle paths, 20 respondents said 'Yes' and 21 said 'No'. Less HGV traffic', 24 respondents said 'Yes' and 20 said 'No'. For 'improved road maintenance', 55 respondents said 'Yes' and 3 said 'No'. # Please make any other comments.

- Speed of all traffic entering and exiting the village at all times of day and night. If the village was to be expanded this would be of great concern.
- Traffic calming is needed on Hollowgate Hall, children play at the bottom and horses are about.
   This is an accident waiting to happen.
- More control over who lives in the old peoples bungalows i.e. for local people.
- Would like to see the speed drop on cars that come in village as some come through the village at speed and speed bump is needed. The rest of the village is lovely and nice.
- The traffic near the school when children are going to school and coming home. There is nowhere for the cars to park.
- It would be nice if more facilities were provided for the young people in the village, so that they stop playing on the roads. Parents often block the road outside the school when dropping off / picking up their children from school, this can cause difficulties for local residents.
- I am fed up with the speed of drivers leaving the village toward Blyborough.
- People who have off road parking should use it instead of parking on the roadside.
- Consider the impact of development on the dangerous and unlit road junction at the top of the hill with the B1398. Needs proper street lighting as well as proper traffic calming measures and signage. Ensure that future development is not controlled by one main landowner, and allow sensitive infill conversions where appropriate and to the benefit of villagers.
- To consider road junction at the top of Hollowgate Hill nr B1398. This junction needs some lighting at night. Better speed calming north or south on B1398 approaching Hollowgate Hill junction, i.e. light up slow signs (like Glentworth). Speed calming coming down Hollowgate Hill into the village needs light up signs. Make sure that developments are sympathetic with the local environment, and local landowner does not have total control of the developments.
- Possible speed humps on Hollowgate Hill to stop speeding traffic. Also to deter motorists cutting through village to Scunthorpe and Gainsborough Road.
- No ball games notice on bus shelter, respect it for what it is.
- Q6, I am reluctant to do a box ticking exercise for this question, it would depend on what type of development. Q8, For a village such as ours I think we have an excellent playing filed and football pitch. Whilst I am in favour of continually improving and supporting these, I don't think we actually need more of them. Q3, I would like to see more single storey dwellings but not typical bungalows.
- I would like to see the grass verges cut more often and perhaps the road sweeper here more
  often too. Maybe the return of the rubbish skip we used to have.
- Need a footpath between public house and war memorial. Spring water on Hollowgate Hill needs remedying. Brownfield sites in village need to be developed to improve appearance of village. Village signage (speed signs, Willoughton signs) needs cleaning.
- My impression is that the survey is heavily weighted towards bringing land into use for housing. This ignores the fact there appears to be no demand in Willoughton for new housing construction. Planning permission for sixteen houses was granted in early 2001, only three of which have been built. The three permissions in Northfield lane and nine in Hollowgate Hill / Long Lane have not been started. As the developer has had no confidence to build there cannot

be a demand. In December 2001 WLDC received further planning applications for 16 more houses all on 'windfall' infill sites; planning was refused on many grounds but included the apparent lack of demand as existing permissions had not been built, ample land having been provided for developments which were not taking place. I attach the relevant first eight pages from the planning services report at that time.

- My impression is that the survey is heavily weighted towards bringing land into use for housing. This ignores the fact there appears to be no demand in Willoughton for new housing construction. Planning permission for sixteen houses was granted in early 2001, only three of which have been built. The three permissions in Northfield lane and nine in Hollowgate Hill / Long Lane have not been started. As the developer has had no confidence to build there cannot be a demand. In December 2001 WLDC received further planning applications for 16 more houses all on 'windfall' infill sites; planning was refused on many grounds but included the apparent lack of demand as existing permissions had not been built, ample land having been provided for developments which were not taking place. Rather than new housing, I believe the village needs an improvement in recreational facilities. The children's playing field could do with updating to encourage children to play there safely, rather than on the roads which is dangerous considering the amount of traffic through the village.
- Footpaths, it would be good if outlying areas of Willoughton such as those on Gainsborough Lane where better linked to the village. Cycle path, it would be nice if Hemswell and Willoughton were linked by a cycle path. The speed of vehicles passing through the village is far too fast, especially when there are children playing and race horses exercising.
- A more coherent public footpath network would encourage wide use without detriment to the farms. For example concession to join Northfield Lane and Westbeck Lane via Huckerby. Northfield Lane to Gainsborough Lane and through to Hemswell.
- I have lived in the village for 30 years. Over that time the number of workers employed on the farm has reduced significantly. That is perhaps inevitable. Unfortunately however it means that now many houses are occupied by people having no real connections with the village. But I cannot see a solution.
