

# **CANDIDATE'S REQUEST FOR A COPY OF THE REGISTER OF ELECTORS AND ABSENT VOTERS' LISTS**

**Under the provisions of the Representation of the People (Amendment) Regulations 2002 a Candidate may request a copy of the Register of Electors for the area where they are standing for election. Such a request must be made in writing by the candidate.**

To request a copy of the Register of Electors for the ward where you are standing as a candidate please fill in the attached form and return it to the Electoral Services Section as soon as possible.

Details of electoral numbers can also be obtained by contacting the staff in the Electoral Services Section on 01427 676576/680.

Upon receipt of your written request a copy of the Register for the appropriate ward will be forwarded to you immediately upon completion of a valid nomination paper.

## **USE OF THE FULL REGISTER OF ELECTORS**

Please be advised that, other than for electoral purposes, you may not:

- (a) supply a copy of the Register to any person;
- (b) disclose any information contained within it unless that information is also contained in the Edited Register
- (c) make use of any such information

Note: The above provisions are contained in the Representation of the People (England & Wales) (Amendment) Regulations 2002. Under these Regulations anyone who fails to observe these conditions is committing a CRIMINAL offence. The penalty is a fine of up to level 5 on the standard scale (currently £5000).
